Post the orientation, the candidate will move into a more specialized training phase within their specialized areas.

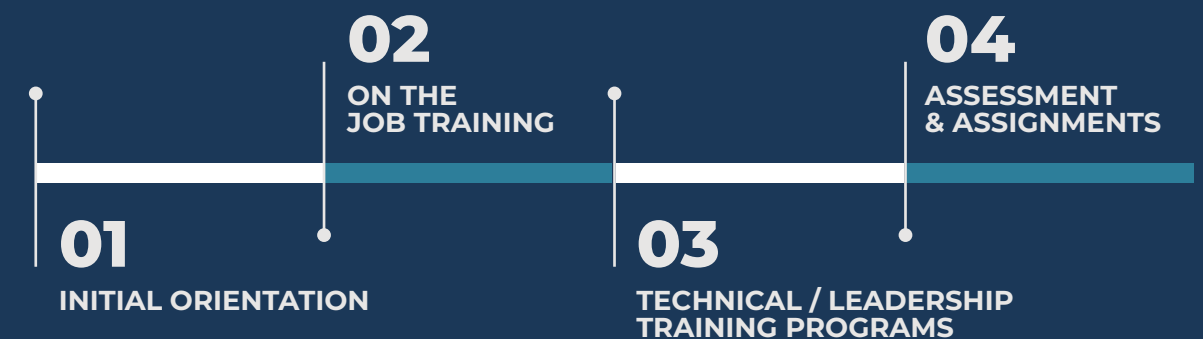
In your assigned units, a mentor will guide your integration and growth, providing personalized advice and fostering a supportive and collaborative learning environment.
